



ACADEMIC LICENCE AGREEMENT

This license agreement hereby dated _____ between Longbelly Entertainment Ltd [hereafter named LICENSOR] and

_____ hereafter named the [LICENSEE] and sets out the Terms & Conditions of use for the film **Ancestral Voices:** _____ documentary [hereafter named FILM]. The FILM is wholly the property of the LICENSOR and maintains ownerships over any licensed products, materials, and/or services.

LICENSEE acknowledges this licence is a Legal Agreement between both Parties and agrees that LICENSOR or its third-party licensors own all rights, title, and interest in and to the FILM.

The license granted hereunder is conditioned upon LICENSEE's acceptance of the terms set forth herein and constitutes the entire understanding of the parties. Any amendments, changes, or modifications shall have legal effect and be binding only if made in writing and signed by both parties.

The license is being granted for educational purposes within the physical premises of the LICENSEE'S institution. Provided that admission is not charged for viewing the FILM, it may be used for in-class instruction, library research, extracurricular activities, free public screenings and similar activities within the boundaries of the LICENSEE'S educational facility and internal networks.

This fee is a one-time payment that provides unlimited access to Staff and students. The fee is based on 'Organisational Size' reflective of the student membership.

Licence Fees determined by your 'Organisational Size', are as follows:

An Organisational Size of 1-500 people one-time licence fee will be £370/\$500 (no VAT)

An Organisational Size of 500 -2000 people one-time licence fee will be £650/\$880 (no VAT)

An Organisational Size of 2000 + people one-time licence will be £850/\$1150 (no VAT)

CONDITIONS:

The LICENSOR will provide the LICENSEE with a DVD or Digital File (MP4) upon completion and payment of the licence, based on the LICENSEE's preference.

The LICENSEE agrees that it may not duplicate, edit or transform the film, telecast, cablecast, broadcast, or upload the FILM to the (public) Internet nor may they lend, rent or donate the FILM to another organisation.

The LICENSOR will provide the LICENSEE with electronic publicity materials (if any) and this license agreement.

The LICENSEE hereby expressly agrees that the FILM shall be used only for the permitted purposes as set forth in this AGREEMENT and for no other purpose.
