

COMMERCIAL LICENCE AGREEMENT



This license agreement hereby dated _____ between Longbelly Entertainment [hereafter named LICENSOR] and _____ hereafter named the [LICENSEE] and sets out the Terms & Conditions of use for the film, **Ancestral Voices**: _____ [hereafter named FILM].

The FILM is wholly the property of the LICENSOR and maintains ownerships over any licensed subscriptions, products, materials, and/or services.

LICENSEE acknowledges this licence is a Legal Agreement between both Parties and agrees that LICENSOR or its third-party licensors own all rights, title, and interest in and to the FILM. The license granted hereunder is conditioned upon LICENSEE's acceptance of the terms set forth herein and constitutes the entire understanding of the parties. Any amendments, changes, or modifications shall have legal effect and be binding only if made in writing and signed by both parties.

The license is being granted for the purposes of a non-broadcast, public exhibition of the FILM, the fee of which is calculated based on the expected 'Group Size'; the capacity of the venue and numbers expected to be in attendance.

Licence Fees determined by your 'Group Size', are as follows:

A Group Size of 1 - 250 people, single screening licence fee will be £250/\$335 (no VAT)

A Group Size of 500 – 1000, single screening licence fee will be £400/\$535 (no VAT)

A Group Size of 1000 + single screening licence fee will be £600/\$800 (no VAT)

CONDITIONS:

This licence is without warranty, a single non-exclusive, non-transferable license for the limited, non-broadcast, public exhibition of the FILM, **Ancestral Voices**: _____ to an estimated audience of _____ people on _____ [SCREENING DATE], in _____ [LOCATION].

The LICENSOR will provide the LICENSEE with a DVD or Digital File (MP4) upon completion and payment of the licence, based on the LICENSEE's preference.

The LICENSOR will provide the LICENSEE with electronic publicity materials (if any) and this license agreement.

The LICENSOR agrees that the LICENSEE may charge admission to the screening(s) and retains all revenue generated from ticket sales.

The LICENSOR grants the LICENSEE license to screen the FILM on the SCREENING DATE(s) indicated only, subject to the terms and conditions specified herein.

The LICENSEE hereby expressly agrees that the FILM shall be used only for the permitted purposes as set forth in this AGREEMENT and for no other purpose.

The LICENSEE agrees that if they require any additional SCREENING DATE(s) to exhibit the FILM, they will request a secondary signed agreement from the LICENSOR

The LICENSEE agrees that it shall not permit the FILM to be duplicated, sold, loaned, transferred, televised or made available online or to any other party not contained herein at any time or in any manner other than as provided for in this AGREEMENT.
